In consideration of the granting of such credit facilities, the purchaser agrees that should collection and/or legal action be taken by ALS Group for the recovery of any moneys due and payable by the purchaser to ALS Group, the purchaser hereby agrees to be responsible for, and to reimburse ALS Group for all costs and expenses, including commissions, which may be incurred or become payable in any collection and/or legal action taken for recovery of moneys due and owing. In this regard costs include legal costs on a solicitor-client basis.
